### PN Selection Process

Steps 1-6 will be used in the PN selection process.

**APPLY TO COPIAH-LINCOLN COMMUNITY COLLEGE**

- 1. Complete Copiah-Lincoln Community College official application
- 2. Must have an accredited high school diploma or its equivalent
- 3. Must have on file at the campus you prefer to attend: an official high school transcript from an accredited high school showing graduation or satisfactory scores on the high school equivalency exam, and transcript(s) from previous college(s) attended. Send to:

### PN SELECTION PROCESS REQUIREMENTS

- 4. Have on file with Co-Lin an ACT score of 16 or above and math and reading minimum score of 12
- 5. Register for the *PN ATI TEAS®* at Copiah-Lincoln Community College. **Applicant must meet ACT requirement prior to registering for test.** (See back for registration dates)
- 6. Take the *PN ATI TEAS®* exam at Copiah-Lincoln Community College (Testing Cost: \$65.00) See back for testing dates.

### AFTER ACCEPTANCE INTO THE PROGRAM

- 7. Attend mandatory practical nursing orientation
- 8. Submit Health Occupations application
- 9. Participate in drug and alcohol testing and a criminal history background check
- 10. Submit Health Form signed by a physician

\*Please note: If you fail to meet any of the deadlines, you will not be considered for entrance into the program.

## What is the ATI TEAS® exam?

The Assessment Technologies Institute TEAS® exam is a computerized test specifically designed to assist in the selection of practical nursing students. It is an excellent indicator to assess if the student is academically prepared for the practical nursing program.

Your ATI TEAS® results will be available to you on your testing date.

Copiah-Lincoln Community College will accept scores taken within the last 3 years from current testing date.
