4. Have on file with Co-Lin an ACT score of 16 or above and math and reading minimum score of 12

- 5. Register for the PN program and PN ATI TEAS® at Copiah-Lincoln Community College. **Applicant**
- must meet ACT requirement *prior to registering* for test. (See back for registration dates)
 - 6. Take the PN ATI TEAS® exam at Copiah-Lincoln Community College

(Testing Cost: \$65.00) See back for testing dates. **AFTER ACCEPTANCE INTO THE PROGRAM**

What is the ATI TEAS® exam?

The Assessment Technologies Institute TEAS® exam is a computerized test specifically designed to assist in the selection of practical nursing students. It is an excellent indicator to assess if the student is academically prepared for the practical nursing program.

When and where can I take the ATI TEAS®?

Also available on this site, you can purchase the TEAS® Online Practice Assessments Form A and Form B for the cost of \$80. Or you can purchase the comprehensive study package which includes: practice assessments A and B, study manual and smart prep tutorial for \$249. Your ATI TEAS® results will be available to you on your testing date.

What if I've already taken the ATI TEAS® exam?

If you have taken the ATI TEAS® Exam and would like to use those scores, please login to ATI @ www.atitesting.com to retrieve your scores and bring them with you the day of registration. Copiah-Lincoln Community College will accept scores taken within the last 3 years from current testing date.
