As we draw to the close of another semester, we are so grateful for your willingness to follow safety guidelines and work diligently to continue your education during these difficult times. We have been granted funds to distribute to students who are completing their courses with an emphasis on helping those students who receive financial aid. All students who are eligible will receive some level of award based on credit hours that you either completed in the Fall of 2020 or are currently enrolled in. This includes virtual only students and dual enrollment students. The hourly rate is approximately \$20 per credit hour. So, a student enrolled in 15 hrs. will get just over \$300. If you were enrolled in 15 hrs. for both Fall 2020 and Spring 2021, you should receive approximately \$600.

Please be on the lookout for emails from BankMobile with instructions on how to receive your funds. If you have not set up an account with BankMobile, please contact the business office at 601-643-8463 for help with that process.

As always, we want to support you and look forward to being able to do the same thing during the 2021 summer terms as well. With a smaller number of students, the per hour rate should be substantially higher for the summer terms. Any amounts distributed after that will depend on continued funding availability.

These funds will be distributed the week of April 26-April 30. Thank you for your patience as we work through this process.
