- □ 2. Complete and have on file a Copiah-Lincoln Community College official application
- $\Box$  3. Must have on file an official high school transcript from an accredited high school showing graduation or satisfactory scores on the high school equivalent exam, and transcript(s) from previous college(s) attended
- ☐ 4. Must have an ACT score on file in the Co-Lin Admission Office

In order to test for selection to the Cosmetology program, Steps 1-4 must be completed no later than: September 29, 2025 for the January 2026 class / May 4, 2026 for the August 2026 class. \*\*

- ☐ 6. Take Cosmetology Aptitude Test (CSAT) at Co-Lin, Wesson campus (See the timeline below for testing dates. Bring photo ID for testing.)

#### \*\*What if I am a high school senior and won't graduate until May and can't meet the May 3 deadline?

If you are currently a high school senior and will not graduate until May, you will follow the same steps, sending a **partial** transcript by May 1, with your final transcript due after your graduation. Please have your high school counselor contact the Career-Technical Division for needed information at 601-643-8324.

#### How do I register for the CSAT?

To register for the CSAT call 601-643-8324 during the week of October 6-10, 2025 or May 4-8, 2026.

When/where is the testing day for the Cosmetology program? Please see the timeline on page 1.

Testing dates are at 8:30 a.m., Fortenberry Building, Career-Tech Computer Lab (next to the Cosmetology Department), Wesson campus. You will attend only one testing date.

#### When does the Cosmetology program accept new students?

A new class begins each January and August.

#### When/Where is the required Cosmetology Orientation for the admitted students held?

See timeline on page 1 for date. The Cosmetology Orientation will be held in the Cosmetology Department, Fortenberry Building.

#### What is the CSAT?

This is a non-computerized test designed to evaluate artistic ability and line, color, and figure perception.

Cost: No charge Time Limit: One (1) hour

When: On your testing date (arrive no later than 8:30 a.m.)

Where Fortenberry Building, Career-Tech Computer Lab (F9/Community Learning Lab) – Wesson campus.

#### What if I have already taken the CSAT? May I retake it to improve my score?

If you have taken the CSAT at Co-Lin your scores are valid for up to 3 years. You may retake the CSAT on the test date.

## How will the tests be used for cosmetology selection?

Results of the tests will be utilized, along with your ACT score, to determine eligibility for program admission.
